2007 beginnenden Zusammenarbeit steht vor allem die Implementierung eines Programms zur Aus-, beziehungsweise Weiterbildung von Staatsbeamten Montenegros, welche sich sowohl in der Diplomatischen Akademie in Wien, als auch in Brüssel mit Integrationsthemen auseinandersetzen werden. Im Hinblick auf die anstehende Kooperation wurde der Außenminister der Republik Montenegro, Miodrag Vlahovic, am 23. Oktober 2006 an die DA eingeladen. Aus seinem Vortrag zum Thema „*Europe and the Balkans*“ ging deutlich hervor, dass der Partner Montenegro mit Hilfe der DA die vorhandene starke Bildungskultur zusätzlich ausbauen und sein volles Potenzial auch für die Diplomatie ausschöpfen will. In Anbetracht dessen steht einer erfolgreichen „*Integration*“ der Republik Montenegro – zumindest mit Hinblick auf die Zusammenarbeit mit der Diplomatischen Akademie Wien – nichts mehr im Wege.

Does Central Europe Still Exist?

History, Economy, Identity

In an influential article published in 1986, Timothy Garton Ash posed the question: "Does Central Europe Exist?" Writing at that particular historical moment, he was able to dissect the myths and realities of Central Europe with a remark that "Central Europe is back." Since that time, however, much water has passed under the bridge – the Cold War has ended and the EU has expanded. In early November 2006, the DA held a major international conference to discuss the question "Does Central Europe Still Exist?". The discussions and debates showed that Central Europe defies precise definition either geographically, historically or culturally. In the end, the general consensus was perhaps best expressed by Otto Pick, Director of the Diplomatic Academy, Prague, who noted that "The idea of a politically, strategically and economically coherent region had some use in the past, but at the present it lacks meaning, purpose and validity." "The region", he argued "is now part of Western Europe and of a wider Euro-Atlantic community. The cultural growing together in the region was localized and relatively brief. It represents an interesting, though heavily idealized, phenomenon which cannot be resurrected."

Speaking for Georgia in Vienna

"Our commitment to change is not based on the goal of satisfying the demands of international institutions or other external actors. Rather – it is based on the core values and principles that nurture our people's democratic aspirations," said Zurab Nogaideli, Prime Minister of Georgia when he visited the Diplomatic Academy of Vienna before his speech at the OSCE on October 27, 2006. Mr. Nogaideli underlined that the very essence of the transformation now underway in Georgia is that institutions and not individuals are driving and sustaining the reform process. He clearly stated the need for replacement of the frozen conflicts in South Ossetia and Abkhazia

with solutions that produce lasting peace through opening these regions economically and politically. After the speech – thanks to the Georgian Embassy – we had the chance to taste delicious Georgian wines. This gave me a good opportunity to hold an interview with Mr. Nogaideli about the education system in Georgia. He mentioned that recently there was a national educational reform, which is based on the US education structure and turned the system into a success story, free of corruption. He pointed out the importance of languages and emphasised that besides English – without any special preference - many other languages of both regional and worldwide importance are learnt by Georgian students. In connection with diplomatic training Mr. Nogaideli said that at present there was no diplomatic academy or similar institution for young diplomats in the country. Students with an ambition for a career at the Georgian Foreign Ministry are encouraged, and supported, to complete special studies abroad, with the Diplomatic Academy of Vienna being one of the preferred institutions with a very good reputation in Georgia.

In this academic year we have three Hungarian students studying at the Diplomatic Academy of Vienna (Márton Kerkápoly, Márton Kovács enrolled in SPIS, Bernadett Valéria Marton in M.A.I.S.). Due to the fact that they already belong to a new generation, we would presume that for them the historic events of 1956 were either only a chapter in the history book or an anecdote told by elder family members. Yet we see the fire burning in their eyes when they talk about the history and culture of their country and their goal of introducing a relatively small but unique nation of the world to their fellow students and everyone who is interested, and we realize that they want to do something for their country. This attitude must have been the motivation for setting up a small exhibition in the "bar" of the Diplomatic Academy (carried out by Bernadett Valéria Marton) in commemoration of the events of 1956 and the spirit of student colleagues of that time. The Hungarian Revolution of 1956 began as a student demonstration that turned into a spontaneous nationwide revolt against the Communist government and the Soviet occupation, lasting from October 23rd until November 4th, 1956. Across Hungary, thousands organized into militias, battling the State Security Police (AVH) and Soviet troops. Impromptu councils wrested municipal control from the communist party, and demanded political changes. The new government of Imre Nagy declared its intention to withdraw from the Warsaw Pact, declared neutrality and pledged to re-establish free elections and the multi-party system. In spite of an initial promising success, by November 4th the Soviet Politburo was ready to quash the revolution. A huge Soviet force invaded Budapest, killing thousands of civilians. Organized resistance ceased by November 10th, and retaliation begun. An estimated 200.000 Hungarians fled as refugees. Over 400 people were executed and more than 23.000 were imprisoned in work camps.

DA Students Take the Initiative

This year's Diplomatic Academy Student Initiative (DASI) is highly active and one may expect the realisation of many promising projects. In a vote that was marked by an astonishing high participation the "Burkina Faso – Hilfe Direkt" charity project and the "Can the Millennium Development Goals still be reached" conference have been chosen to be the main focus of this year's DASI. The conference is planned for May 11th, 2007. Students are hoping for great success in raising funds, as 20.000 Euro would allow a shared contribution to "Burkina Faso – Hilfe Direkt" and a scholarship for a student from a developing country. A second charity project – Akshaya Patra Initiative in India – would be the beneficiary of potential funds beyond 20.000 Euro. Other events being planned are: The DA Students Ball (this year's Ball Committee is planning a traditional Viennese Ball with international elements to take place at the DA on May 5, 2007); Bar & Events (including a number of theme parties - Halloween, Thanksgiving and Carnival) and DA/SAIS Bologna Conference (A joint initiative of the DA and Johns Hopkins University, Bologna to organise a conference, probably here at the DA). It is a year full of events! Some students are enthusiastic about being part of the supply curve and some others would like to shift the demand curve to the right, despite the supply of exams being inelastic. 

Thanksgiving at the DA

Three hundred-eighty five years after the first Thanksgiving feast, 20 DA students celebrated with their American peers the American holiday, Thanksgiving, traditionally on the 4th Thursday of November. A nearly traditional dinner was had, with turkey and gravy, rice, mashed yams, baked potatoes, and mixed vegetables. Missing was only stuffing (!), squash, cornbread, cranberry sauce (!), and the typical dessert - pumpkin pie (!). In lieu of pumpkin pie, there was an abundance of wines. The great feast harks back to the first year of Plymouth Colony. In 1621 the surviving half of the Pilgrims of the Mayflower sat down in peace with their neighbors, the Wampanoag Native Americans, to feast on duck, geese, clams, eel, venison and wild vegetables. The motivation for the three-day feast was actually not for everyone to get fat and happy - hardly a Puritan quality, but rather to give "thanks" to God and particularly to the Native Americans, who had helped the Pilgrims immeasurably to survive the harsh winter and to have a good harvest. Today, in the US getting fat (market inefficiency) and happy (demand equilibrium) has definitely surpassed the importance of giving "thanks" (private subsidies). So, go ahead and eat to your heart's desire, good luck with the wishbone (congratulations and good luck Marcela Rodriguez!), and only if ambitious, give "thanks", even if to the sacrificed turkey.
